## **POLICY**

Motion-That the Commission adopts revisions to Policy 1.01, Administration of PTC Policies, to update the responsibility for establishing, reviewing and the approval process of all PTC policies - was made by Commissioner Wozniak, seconded by Commissioner Deon and passed unanimously.
