# NEW BUSINESS POLICY LETTERS

### **AGREEMENTS**

Motion-That the Commission approves negotiation and execution of the Agreements, an Amendment, a Supplement and a Memorandum of Understanding, and approve a revision to an award for the items listed in memos "a" through "h":

- a. Reimbursement Agreement with Aqua PA for Aqua PA to reimburse the Commission the cost for the installation of a water line as part of the I-95/I-276 Interchange (DB-242, MP 355.63); at an approximate reimbursement of \$250,000.00;
- b. Amendment to our agreement with Notary & Copy Stop, Inc. for E-ZPass distribution; exercising the option to renew the agreement for an additional year (November 2018 November 2019);
- c. Supplemental Agreement with Peoples Natural Gas Company (PNGC), to reimburse PNGC the cost for the engineering and utility relocation work necessary for the replacement of Bridge WB-454 at MP 53.66, for an increase of \$27,403.21 due to a re-design of the proposed gas line relocation increasing the overall length to avoid mine voids; for a revised not-to-exceed amount of \$167,346.62;
- d. Reimbursement Agreement with the Pennsylvania Game Commission to reimburse the Game Commission for its expenses to cultivate Willow Oak trees from seed for three (3) years (for future planting) to fulfill mitigation commitments as part of the I-276/I-95 project; at a not-to-exceed amount of \$25,000.00;
- e. Agreement with PA American Water (PAW), for PAW to install approximately 3,000 linear feet of water main (including valves, services and appurtenance), and for temporary road restoration along Cecil-Sturgeon Road necessary for the maintenance facility along the Southern Beltway; at a not-to-exceed amount of \$473,395.00; the Commission will be responsible for final road restoration of Cecil-Sturgeon Road after installation of the water main;

- f. Memorandum of Understanding with the PA Department of Conservation and Natural Resources (DCNR) for DCNR to transfer right-of-way to the Commission for the replacement of the bridge at MP A130.30 (Edella Road Bridge); in exchange for the right-of-way, the Commission will install an emergency access gate at MP A130.30 SB for emergency use by DCNR;
- g. Revision to the award for property management services for the Mon/Fayette Expressway, Rt. 51 to I-376, that was awarded to Interstate Acquisition Services (August 21, 2018, item F-10f); to award to Century Engineering, Inc., due to Century's acquisition of Interstate Acquisition Services;
- h. Agreement with BOARD Americas for software and cloud hosting services to manage the development of the operating budget and for reporting and forecasting analyses; at a not-to-exceed amount of \$1,371,006.00 for 5-years.

Acquisition of Right-of-Way #14080-A (Timothy & Sarah Godak), a total take parcel necessary for the total reconstruction project from MP 49.00 to MP 53.00 by authorizing payment of \$148,399.66 representing fair market value, pro-rated taxes, recording fees and mortgage satisfaction to Tri-State Paralegal Services, LLC, escrow agent; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that might be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owners is contingent upon the delivery of a deed as prepared by the Legal Department;

Hathaway), a total take parcel necessary for construction of the Mon/Fayette Expressway by authorizing payment of \$159,081.35 representing fair market value, pro-rated taxes, recording fees and housing supplement to Closure Settlements, LLC, escrow agent; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of a deed as prepared by the Legal Department;

Acquisition of Right-of-Way #9085 (MUY Properties-NE, LTD), a partial take parcel necessary for the Pre-Entry ITS from MP A20.00 to MP A131.00 by authorizing payment of \$2,100.00 representing fair market value to MUY Properties-NE, LTD; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of a deed as prepared by the Legal Department;
- g. Acquisition of Right-of-Way #14093-A (Nancy L. Matheys), a total take parcel necessary for the total reconstruction project from MP 53.00 to MP 57.00 by authorizing payment of \$141,600.48 representing fair market value, pro-rated taxes and recording fees to Fee Simple Settlement LLC, escrow agent; authorizing additional payment of \$350.00 representing Section 710 statutory damages to Nancy L. Matheys; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value is contingent upon the delivery of a deed as prepared by the Legal Department.
